To write an article review in APA format, start by formatting the excerpt of the article. Read the article and define standard APA sections such as abstracts, introductions, methods, studies, and results. An APA article ends with a discussion section. For others to find a specific video, they can search the video title and find what they're looking for, but in most cases, people's screen name or username is also required to find the right channel or video. Your goal should be a completely descriptive title craft that can stand alone and without further details. A reader who browses paper titles in an online database should be able to read your title quickly and know exactly what your paper is about. You should also avoid words that serve a real purpose or do not convey basic information. Examples of such words and phrases include An Essay..., A Study..., method, or results. The APA publication guide recommends that your title should be up to 12 words long. The next item on your title page is the line name, which lists the author's name as well as their corporate links. Listing your first name, middle initials, and last name is the recommended format. It does not include abbreviations of titles or degrees, such as Dr. or Ph.D. Corporate relationship, where research is conducted, should most often be a college or university. In some cases, the research may have been supported by more than one organization. In such cases, it contains only two links if both schools have offered significant support for research and list only two links for each author. What should you do if you are not affiliated with an academic institution when conducting research? In this case, the APA recommends listing the city and residence status instead of the academic relationship. A working head must be added to the upper-left corner on all pages, including the title page (if it is student paper, it is not required on the title page). All pages, including the title page, must also have a page number in the upper right corner. The first line of your title page should be left-aligned at the top of the page using the following format: Running head: START OF PAGE Note that the working head should not be listed as up to fifty characters, including letters, spaces between words, and punctuation marks in capital letters of your title. Your title, name and institution should be double-spaced and centered on the page. Student documents must also include the assignment end date just below the institution information. The APA's guidelines are slightly different for papers intended to be published scientifically in a professional journal. In addition to the basic elements on a basic title page, a professional paper must also include a head that works with an abbreviated version of the paper's title. A professional paper must also include an author's note under corporate membership. This note must contain the author's name, the ORCID ID symbol, and the URL for the ORC ID. ORCID ID is an alphanumeric code used to identify scientific and academic authors. If an author does not have an ORDID iD, their name must be nned out.
